DISCIPLINARY PROCEEDINGS AT THE FOCUS OF HIJ, HJC AND HPC

Investigations and disciplinary proceedings of judges and prosecutors were the focus of a joint meeting initiated by the actors involved in this process – the High Judicial Council, the High Prosecutorial Council and the High Inspector of Justice.

Once it was established, on February 1st, 2020, HIJ started the first disciplinary investigations against magistrates, and subsequently, the HJC and the HPC adopted their respective regulations on disciplinary proceedings. The development of the first disciplinary proceedings submitted by HIJ to both Councils, based on the new

justice reform legislation, has prompted the heads of the new institutions, High Inspector of Justice Artur Metani, Chairperson of the HJC Naureda Llagami, and Chairperson of the HPC Ibrahimi to activate communication and coordination platform to identify issues of common interest encountered during implementation of the law, agreement coordination the implementation of uniform standards, by guaranteeing a regular disciplinary process respecting independence of magistrates.



Complaint Process

Your complaint can be submitted electronically by email, by mail or directly to the High Inspector of Justice Office (HIJ).

When you fill out a complaint form at the HIJ premises in person, you can be assisted by the employees of the Complaint Sector.

You can submit your complaints at HIJ Office from Monday to Friday, 09:00 a.m. -14:00 p.m.

COMPLAINT SECTOR

The HIJ Complaint Sector is responsible for guaranteeing the right of citizens to information and transparency to the public.

This Sector monitors the complaints traceability in the system and provides answers to complainants on their complaint stage. STATISTICS


During **July**, the High Inspector of Justice Office received **122 complaints** made by citizens and institutions.

This total figure resulted in:

101 compaints filed by citizens;

21 complaints filed by institutions.

41 phone calls with citizens, who asked information about their complaint stage. **25 meetings** with citizens.



The High Inspector of Justice Office has performed the standard confirmation process of receiving complaints for all the new complaints submitted during July, 2021.

Complaints against judges and prosecutors are referred to the inspectors and they are at different stages of the process such as the initial consideration, verification and the archiving together with relevant decisions.

The High Inspector of Justice participated in the meeting held on July 23 "Justice reform - 5 years later: finalization of the cross-sectoral justice strategy 2021-2025"

Below, the full speech of the High Inspector of Justice held at this meeting.

Honorable Mrs. Gjonaj, Honorable Ambassador Soreca, Honorable Ambassador Kim, Distinguished colleagues of justice institutions, Dear guests,

The development of a new strategy comes at a time when all the justice system institutions have been established, thanks to the constitutional and legal structure developed for a new system and a new approach to the justice system. We are at the

moment when the cycle of establishing new justice institutions has ended, as well as equipping them with the necessary infrastructural and human capacities for bringing strategic priorities for the country to life.

The past five years served to understand the importance of the need to transform one of the most delicate but crucial pillars in a state of law. The High Inspector of Justice, during his 17-month journey, has had comprehensive challenges in setting up the office and becoming functional-from providing working facilities, to filling the vacancies with human resources, challenges which we are still facing.

However, in my remarks, I would like to focus on strategic planning, as the main system that guarantees the coordination and implementation of the constitutional institutions' policies in the long run, to ensure an effective and sustainable
