COMPLAINT SECTOR

The HIJ Complaint Sector is responsible for guaranteeing the right of citizens to information and transparency to the public. This Sector monitors the complaints traceability in the system and provides answers to complainants on their complaint stage. As part of the transparency program, in order to increase the communication with the interested citizens, the High Inspector of Justice Office in addition to the official address and the official Web, has made available the telephone number +355 4 2217217.

STATISTICS

During September, the Office of High Inspector of Justice received 70 copmplaints made by citizens and institutions.

This total figure resulted in:

65 complaints filed by citizens;

5 complaints filed by institutions;

37 phone calls with citizens, who asked information about the stage of their complaints or asked for assistance in how to complete the Form of the Complaint.

29 meetings with citizens.



The High Inspector of Justice Office has performed the standard confirmation process of receiving complaints for all the new complaints submitted during September, 2021.

Complaints against judges and prosecutors are referred to the inspectors and they are at different stages of the process such as the initial consideration, verification and the archiving together with relevant

MEMORANDUM OF UNDER-STANDING SIGNED BETWEEN HIJ AND THE INSPECTORATE TO THE SUPREME JUDICIAL COUNCIL OF BULGARIA

The High Inspector of Justice of Albania and the Inspectorate to the Supreme Judicial Council of the Republic of Bulgaria formalized the cooperation between them by signing a joint memorandum of understanding.



The memorandum, which was signed at the premises of HIJ, between High Inspector of Justice Artur Metani and Inspector General Toedora Tochkova, provides for the exchange of best practices and experiences, in the framework of verifying complaints procedures, investigating disciplinary violations, initiating disciplinary proceedings against magistrates, as well as implementing institutional and thematic inspections.

The exchange of information on the legal system and legislation in the field of disciplinary proceedings against magistrates, law enforcement measures in their areas of jurisdiction and their international experience applicable during the disciplinary investigation procedure, including the jurisprudence of the European Court of Human Rights, is another dimension of the memorandum of understanding along with the exchange of experience on how to communicate with the public in order to guarantee the principle of transparency and protection of personal data and the integrity of magistrates.





HIGH INSPECTOR OF JUSTICE, ENCOURAGEMENT FOR AMBITIOUS JURISDICTION STUDENTS

Office of the High Inspector of Justice as part of its vision, has the hospitality for professional practice of ambitious students, who want to deepen their knowledge, by looking closely at how HIJ works.

In September, Maxim Kasolowsky, a student from Germany who has chosen to study law at Oxford University, has joined the HIJ team for an internship.

Mr. Kasolowsky focused his practice at HIJ in disciplinary investigation against judges and prosecutors, a practice which in Albania



is now carried out by a single institution, such as the Office of the High Inspector of Justice, as well as a comparison with European practices.

The High Inspector of Justice Metani and members of the cabinet attended the presentation of Mr. Kasolowski on the best practices of counterpart inspection institutions in Europe, a documentation of his research work at the Office of the High Inspector of Justice.




