MESSAGE OF THE HIGH INSPECTOR OF JUSTICE, MR. ARTUR METANI, ON THE $2^{\rm ND}$ ANNIVERSARY OF THE ESTABLISHMENT OF HIJ

The 1st of February marks two years since the establishment of the Office of the High Inspector of Justice.

These have been two years with daily efforts to establish a public institution and set bureaucratic, democratic standards of its functioning, to establish the best practices of communication, transparency and access of citizens.

At the same time, these two years, despite the lack of human resources, have shown increasing dynamics in the process of the verification of complaints and theestablishment of standards of inspection of the work of judges and prosecutors.

The number and the standards of the disciplinary proceedings conducted, the increased number of the verification of citizens' complaints, the

transparency of decision-making and HIJ institutional life, are already established working standards of the HIJ. For the HIJ, the vision to find a balance between the respect for the independence of magistrates and the public interest in the administration of justice remains unchanged.

The culture of impunity is a standard that cannot be set in one year or two, but day after day with the establishment of solid professional practices, whose aim is to replace it with a new culture, that of the professional and moral integrity of magistrates.

It is about time that the culture of professional and moral integrity within the judicial system replaces the interests against justice. *It is not easy, but it is it not impossible either.*

DISCIPLINARY PROCEDURE IN 2 YEARS OF WORK AT THE OFFICE OF THE HIGH INSPECTOR OF JUSTICE

In 2 years of work, 1 February 2020 - 1 February 2022:

22 disciplinary proceedings submitted to the HJC and HPC by the High Inspector of Justice: specifically, 15 judges and 7 prosecutors;

HIJ has submitted 12 requests for the disciplinary measure "dismissal" in both Councils. Of these, 8 were accepted (5 judges and 3 prosecutors); 2 have been closed without a decision by the HJC and 2 are in process in the respective Councils;

HIJ has submitted 1 request for the disciplinary measure "suspension from office", which has been accepted;

HIJ has requested 5 disciplinary measures "salary reduction", of wich 2 have been partially accepted and 3 others are in process;

HIJ has requested 4 disciplinary measures "public reprimand", of which 1 has been accepted, 1 has been refused and two others are in process;

Of the ongoing proceedings, 4 are suspended by the HJC, pending the decision of the AC.

TYPES OF DISCIPLINARY MEASURES ACCORDING TO THE LAW, FROM EASIEST TO THE MOST SEVERE

- ⇒ Confidential remarks;
- ⇒ Public remarks;
- ⇒ Temporary salary reduction;
- ⇒ Demotion from a position of a higher level to a lower one, or from a higher court / prosecution office to a lower one;
- ⇒ Suspension from office;
- ⇒ Dismissal from office.

COMPLAINT PROCESS AT HIJ

The Office of the High Inspector of Justice continues with intensive work to confirm the complaints carried and those administered since February 1, 2020, when it was established as an institution. To facilitate this process for interested persons, HIJ has published on the official website a special complaint form, which:

- can be completed directly and submitted online;
- can be downloaded, completed and sent by email to info@ild.al
- or by mail at the address Boulevard "Dëshmorët e Kombit", Building no.13, Tirana.
- It can also be completed by presenting at the Office of the High Inspector of Justice, if necessary, to ask for assistance of the team of the Complaints Office.



Upon receipt of the complaint, the High Inspector of Justice within 5 days confirms in writing its receipt. The criteria for the admissibility of the complaint are published on the official website of HIJ www.ild.al, in the section "How to receive complaints".

"The main commitment of the High Inspector of Justice Office is that judicial functions in the Republic of Albania must be performed independently, impartially and with integrity through a system of responsibility and accountability."

STATISTICS

During **February**, the Office of High Inspector of Justice received **79 complaints**, made by citizens and institutions.

This total figure resulted in:

70 ankesa filed by citizens;

9 ankesa filed by institutions;

28 phone calls with citizens, who asked information about the stage of their complaints or asked for assistance in how to complete the Form of the Complaint;

9 meetings with citizens.

The High Inspector of Justice Office has performed the standard confirmation process of receiving complaints for all the new complaints submitted during February, 2022. Complaints against judges and prosecutors are referred to the inspectors and they are at different stages of the process such as the initial consideration, verification and the archiving together with relevant decisions.

COMPLAINT SECTOR AT HIJ

Communication with citizens is part of the daily work of the High Inspector of Justice.

The HIJ Complaint Sector is responsible for guaranteeing the right of citizens to information and transparency to the public. This Sector monitors the complaints traceability in the system and provides answers to complainants on their complaint stage.

ON A WORKING VISIT TO ROMANIA

High Inspector of Justice Artur Metani started a working visit in Bucharest, invited by Mr. Lucian Netejoru, head of the Judicial Inspectorate of Romania, as part of cooperation launched last November with the European Network Justice Inspection Services.

Mr. Metani met with the Minister of Justice of Romania, Mr. Cătălin Predoiu, with whom he talked about the progress of justice reform in Albania, a similar challenge for both countries, as justice reform was an important condition for Romania's membership in the European Union 15 years ago.



The High Inspector of Justice praised the role of Romania in supporting the opening of Albania's accession negotiations with EU, while holding the rotating presidency of the European Union, and said that Romania's contribution with its experience in justice reform within the EU membership process, would be valuable for Albania.

Mr. Metani also talked about issues of justice reform and the Romanian experience during a meeting with the chairwoman of the Romanian Senate Committee on Legal Affairs, Mrs. Laura-Iuliana Scânte.

HIGH INSPECTOR OF JUSTICE HAS WORK MEETINGS IN JUSTICE INSTITUTIONS IN ROMANIA

High Inspector of Justice Mr. Artur Metani, during his working visit to Bucharest, had a series of meetings in the Romanian justice institutions, to get acquainted with the Romanian experience on justice reform, as a similar development in both countries, aimed at reforming the judiciary and boosting the fight against corruption, a process launched earlier in Romania related to its membership in the European Union.

In a meeting with members of the Constitutional Court – Judge Mrs. Mona-Maria Pivniceru, Judge Mr. Cristian Deliorga and Judge Mr. Gheorghe Stan, High Inspector Mr. Metani discussed the changes which justice reform brought about in Romania and Albania, the role of inspections and disciplinary investigations in both countries as well as domestic and European constitutional legislative practice regarding disciplinary measures against magistrates.

The implementation of the justice reform in Romania and the role of the magistrates in the new configuration were the focus of the conversation of the High Inspector Mr. Metani with the President of the High Judicial Council, Judge Mr. Bogdan Mihai Mateescu and later with the





Director of the National Institute of Magistrates, Judge Mrs. Cristina Rotaru-Radu.

Mr. Metani exchanged views on justice reform and its effects on the system and the rule of law, with the chairwoman of the Romanian Senate Committee on Legal Affairs, Mrs. Laura-Iuliana Scântei and the chairwoman of the Legal Issues and Immunities Committee in the Chamber of Deputies, Mrs. Laura-Cătălina Vicol-Ciorbă.

Mr. Metani also met with Prosecutor General Mrs. Gabriela Scutea, while earlier met with the Minister of Justice Mr. Cătălin Predoiu.
