During **October** the Office of High Inspector of Justice has administered **84 complaints**, which were submitted by citizens and by institution . High Inspector of Justice Office has performed the standard confirmation process of receiving complaints for all the new complaints submitted during **October 2024.**

Complaints against judges and prosecutors are referred to the inspectors and they are at different stages of the process such as the initial consideration, verification and the archiving together with relevant decisions






