# EFFICIENCY OF JUSTICE, HIJ HAS APPROVED THE INSPECTION CALENDAR FOR 2025

The High Inspector of Justice has sanctioned the inspection plan for prosecution offices and courts for 2025 at the General Meeting of Inspectors.

For the second consecutive year, thematic and institutional inspections are a priority of the work of the High Inspector of Justice, as an instrument to measure the efficiency of justice in the country, but also as the conclusion of the special working meeting, held last October, with the Unit of Inspectors and the Unit of Assistant Inspectors, to address the findings of the document "Common Position of the European Union", in the framework of the

opening of Albania accession negotiations for the first group-chapter.

The delay of work processes by judges and prosecutors has been the most frequently identified cause of complaints addressed to the High Inspector of Justice during 2024, by citizens but also by institutions, which have forwarded proposals for thematic inspections.

At the General Meeting of Inspectors, it was noted that from the processing of data on complaints related to courts, the court with the highest number of complaints reviewed by the HIJ, with the sub-

## JANUARY OF HIJ IN NUMBER

During January 2025 the Office of High Inspector of Justice has administered 120 complaints, which were submitted 119 by citizens and 1 by institution. High Inspector of Justice Office has performed the standard confirmation process of receiving complaints for all the new complaints submitted during January 2025.

Complaints against judges and prosecutors are referred to the inspectors and they are at different stages of the processing such as the initial review, verification and the archiving together with relevant draft decisions.





- ⇒ Has Had 7 phone calls from citizens, who requested information on the stage of their complaints or Information on completing the complaint form.



### COORDINATOR FOR THE RIGHT TO INFORMATION

In accordance with the principles and rules provided for in law no. 119/2014 "On the right to information", the coordinator for the right to information in the Office of the High Inspector of Justice, enables every applicant the right to be familiar with public information, as well as communicates according to the need with the applicant regarding the processing of the request for public information.

The information provided in the transparency program is published and continuously updated in the register of requests and responses, within the legal deadline.

### **MONTHLY NUMBERS**

During **January 2025**, at the Office of High Inspector of Justice, **17 requests** for information were received, which were processed in all cases within 5 days (the law provides that a response must be return to the applicant within 10 days).




