COOPERATION MEMORANDUM

BETWEEN THE OFFICE OF THE HIGH INSPECTOR OF JUSTICE AND

FACULTY OF LAW OF THE UNIVERSITY "LUIGJ GURAKUQI"

April 4th 2024

The Office of the High Inspector of Justice and

The Faculty of Law of the University "Luigj Gurakuqi" hereinafter referred to as the "Faculty of Law", jointly referred to as the "*Parties*",

Considering the common areas of interest with the aim of increasing public awareness and increasing transparency in relation to the mission, competencies and responsibilities of the High Inspector of Justice;

Appreciating mutual cooperation, in function of joint work, with the aim of strengthening cooperation for legal education and other joint components;

Taking as a basis the mutual will, to create new opportunities and bridges of cooperation that help both parties undertake joint initiatives;

Expressing the deep belief that this cooperation will be further concretized with other joint initiatives and mechanisms in the future,

The Parties (signatories of this Memorandum) have agreed as follows:

Article 1 **Object of the Memorandum**

1. This Memorandum aims to develop a framework for cooperation between the Parties.

2. The Parties agree to develop joint activities and programs, with the aim of deepening and exchanging knowledge in the field of justice, which aim to concretize the mandate of the Parties through joint initiatives.

Article 2 **Cooperation activities**

1. The Parties agree to develop cooperation activities as follows:

- a. Organization of joint activities in the field of justice, including initiatives of an academic nature, research and exchange of necessary experiences;
 - b. Use of joint capacities for the construction of educational programs that serve the students community;
 - c. The possibility of internship for students of the Faculty of Law, at the High Inspector of Justice Office;
 - d. The organization of round tables and lectures that focus on legal and professional education;
 - e. The organization of other joint activities, taking into account the function of the parties.
2. The engagement of students of the Faculty of Law in practical work within the framework of the activity of the Office of the High Inspector of Justice will be carried out taking into account the internal regulations of the institution.
3. The Faculty of Law undertakes, as necessary, to respond to the Office of the High Inspector of Justice, in joint activities and to provide the expertise of academic staff, depending on the joint assessment.

Article 3

Contact persons and communication between the Parties

1. The Parties shall designate one or more members of their staff as contact persons, with responsibility for keeping all communication, exchange of information and necessary preparation for the implementation of this Memorandum.
2. The Parties shall communicate in writing regarding the coordination and necessary preparations related to the cooperation activities provided for in Article 2 of this Memorandum, as well as in general regarding the implementation of this Memorandum.
3. Communication between the Parties shall be in official written form or via electronic mail, but not excluding the fastest forms of communication.
4. The Parties shall immediately notify each other in case of a change of the contact persons.

Article 4

Duration of the Memorandum

This Memorandum is concluded for an unlimited period of time.

Article 5 Financial Costs

Any financial costs resulting from the implementation of this Memorandum are subject to the legislation in force and are within the limits of the budgetary expenditures available to the Parties.

Article 6 Amendments to the Memorandum

Amendments to this Memorandum shall be made in writing, with the approval of both Parties.

Article 7 Resolution of Disputes and Termination of the Memorandum

1. The Parties undertake to resolve any dispute regarding the interpretation or implementation of this Memorandum through friendly and good faith consultations between the Parties.
2. Either Party may withdraw from this Memorandum at any time, by written notice to the other Party.

Article 8 Entry into Force

- I. This Memorandum shall enter into force on the date of signature by the representatives of both Parties.
2. The Memorandum is prepared and signed and kept in 2 (two) original copies, where 1 (one) copy is deposited at the Office of the High Inspector of Justice and 1 (one) copy is deposited at the Faculty of Law of the "Luigj Gurakuqi" University.

Signed in Shkoder on 04.04.2024, in two original copies, in the Albanian language, with equal legal value.
